# **Position Purpose**

The Contract Administrator is instrumental in effectively managing and administrating contracts during the post-award stage of construction projects and services across multiple Capital Delivery projects simultaneously.

The role is accountable for facilitating communication between project teams, processing claims and variations, ensuring contractual compliance, attending contract management meetings, and preparing necessary reports. The Contract Administrator's expertise will contribute to ensuring the accuracy of timely payments and safeguarding Unitywater's contractual obligations. This role supports the successful completion of projects on time and within budget, aligning with Unitywater's commitment to excellence in infrastructure delivery.

The role is responsible for managing the commercial risks and outcomes across programs up to **\$100m per annum**.

### Position Accountabilities

Key functions of the role include:

- Act as a liaison between project teams, clients, subcontractors, and suppliers, ensuring clear
  and effective communication regarding contractual obligations, changes, and milestones.
  Coordinate with internal and external stakeholders to ensure contract terms are understood
  and adhered to, facilitating smooth project execution, and fostering strong professional
  relationships.
- Develop, support, and implement continuous improvement initiatives to enhance the capability and capacity of commercial and contract management practices for capital works contracts.
- Monitor contract budgets and expenditures, ensuring accurate financial tracking and reporting.
   Assist in preparing financial forecasts and variance analyses, providing detailed reports to project managers and senior leadership.
- Implement cost control measures and support the identification of cost-saving opportunities, contributing to the project's financial health and success.
- Ensure the accurate preparation, review, and administration of contract documents in alignment with project requirements and legal standards. Maintain comprehensive and organized contract records, ensuring all documentation is current and compliant with regulations and policies.
- Proactively identify and address compliance issues, facilitating timely resolution to avoid project delays and legal complications.
- Apply and interpret key elements of Australian Standard for Conditions of Contract AS4122, AS 4902, AS 4906 and AS 2124, and interpret (with assistance) the terms of other bespoke contract documentation.
- Engage and collaborate with key stakeholders, including executives, internal customers, staff and suppliers to deliver positive outcomes for the project and organisation.
- Meet relevant ISO standard.
